****Our Guarantee:**

We guarantee our puppies to be in good health to the best of our knowledge. All puppies have been health checked by our veterinarian and are free from obvious defects. All shots are up to date and puppies have been wormed regularly and kept on a strict parasite prevention program. Puppies may be stressed by a change in environment which may cause minor problems, such as, but not limited to, diarrhea. It is the responsibility of the purchaser to seek veterinary care if any illness should arise. Minor health problems are not covered under this contract. Parvo and Corona virus are not covered under this contract. Extreme caution should be exercised at all times until puppy has had all 3 puppy vaccinations.

Boondocks Boxers and Lisa Gammill are not responsible for anything that might happen to the puppy after it leaves our property.

****Buyer Responsibilities:**

Deposits will not be refunded unless illness or death of dog occurs before pickup.
Deposits will not be refunded because you changed your mind.

Puppy must be paid for in full no less than 2 weeks prior to shipping date or all monies paid and all claims to puppy will be forfeited.

1. Have puppy checked by a licensed veterinarian within 72 hours of delivery. Boondocks Boxers must be informed immediately of the examinations results by e-mail or phone. The failure of this will result in cancellation of this guarantee.

2. Provide puppy with routine preventative care, such as, but not limited to:

*Annual examinations by a licensed veterinarian.

*Follow veterinarian guidelines for vaccinations, dewormings, flea and heartworm preventatives.

3. Boxers do not tolerate hot or cold environments and should be kept indoors.

4. Puppy should be fed a high quality food.

5. Both puppy and buyer will greatly benefit from the puppy being properly obedience trained. This is highly recommended by seller.

****Health Guarantee and buyer information:**

1. This puppy is guaranteed until 1 year of age against fatal and life altering congenital disease which adversely affects the health of the animal. This includes severe hip dysplasia, which hampers the dog's movement and natural gait and requires surgery to correct, kidney, heart, pancreas, spine, and liver problems of a severe life threatening or altering nature. If the dog dies within this one year time frame, the buyer must pay for a necropsy to determine reason of death. If reason is congenital, seller will replace the puppy.

2. All items covered under this guarantee are by replacement only. We do not give refunds.

3. A puppy showing any serious genetic or congenital defect will be replaced as follows:

***Dog must show the defect by one year of age. Seller must be informed of the problem within 2 days of the licensed veterinarian's determination and have one report from an unassociated veterinarian stating the same condition and seller will replace the puppy.**

***A puppy with a defect must be returned to the seller in good condition, other than specified defect, or be euthanized if in the best interest of the puppy, with the permission of the seller.**

4. No replacement puppy will be given if the puppy has been bred, spayed, neutered, or euthanized without seller's permission.

5. Replacement puppy will be mutually agreed upon by both parties and will be of comparable quality. It is understood that the replacement puppy may not be from the same parents as the original puppy.

6. Buyer is responsible for all transportation costs to and from the seller on a replacement puppy.

7. No refund, in part or in full, will be given.

8. This guarantee applies to the original buyer only and is not transferable to a second party.

9. Seller will not be responsible for any medical expenses incurred. Buyer is fully aware that owning a puppy/dog means veterinary expenses, and that buyer will be responsible for all payment.

10. As of date of delivery, the puppy has received proper vaccinations and wormings. The buyer has been informed of these and of when future vaccinations are due.

11. This guarantee does not cover an un-even bite. It cannot be determined at a young age the correctness of the bite the puppy will have as an adult. All bites are checked and if your puppy appears to have an extremely un-even bite, you will be notified and may choose a different puppy if desired.

12. This guarantee does not cover undescended testes. Sometimes they do not fully descend until the puppy is 3-4 months old or more.

13. This guarantee does not cover umbilical hernias. If a hernia is noted at puppy's health check, you will be notified. These can be easily repaired when the puppy is spayed or

neutered.

14. Slight heart murmurs are common in boxers and are not covered by this contract. In most cases they are innocent. If our vet detects a slight murmur you will be notified. Any more serious murmurs will be further tested.

15. There are certain disorders that may be caused by environmental factors, such as, but not limited to, allergies, thyroid dysfunction, mange, cancer, and autoimmune disorders. These can be triggered by many things and are not covered under this guarantee.

16. Any physical problems that could be caused by an injury are not covered under this guarantee.

17. There is no guarantee that the buyer will be able to show or breed this puppy/dog regardless of show or breeding potential traits shown as a puppy.

18. Registration papers will be held until proof that the puppy has been spayed/neutered is received by seller.

19. If puppy/dog is sold with full AKC registration, buyer agrees to do proper health testing before breeding.

****Shipping/Delivery**

- 1. Puppies may be picked up at 8-10 weeks of age.**
- 2. Buyer is responsible for making arrangements to pick up puppy in person. No puppy will be sold sight unseen.**
- 3. If buyer cannot receive the puppy before 12 weeks of age, additional charges may be incurred.**

****This contract supersedes any and all previous agreements. This contract is null and void if the terms and conditions are not fulfilled.**

Buyer agrees that he/she understands this contract fully, and that this contract is under the jurisdiction of the State of Texas, in the county of Hopkins. It is agreed that the place of venue shall be in Hopkins County Texas.
